

Climate and elevation

The Canelo Spring Ranch has a mild climate with summer highs in the upper 90's to winter lows in the 30's. Elevations range from 4,500 feet above sea level to 5,700 feet on the southern end of the ranch in the Canelo Hills. Precipitation averages 18 inches falling mostly during the summer monsoon season July-September.





Location Map




